#### **Executive Vice-President's Report**

I hope everyone had a safe and healthy Christmas season. I know it was busy. We are now at the point when the daylight will increase a couple minutes per day, not much but enough to make a difference in a few weeks. Most carriers will still be finishing their assignments in the dark, so be careful. There is no need to rush what you are doing to hopefully finish before dark, safety is far more important. Please don't skip any breaks or lunch, this is part of your day and included in your pay.

As of 12-16-23, we are in a new leave year and our annual leave maximum carryover is 520 hours for the year 2024. We don't know at this point if this figure will carryover into 2025, so please plan accordingly. I know it is early to discuss this, but you don't want to be close to the end of 2024 with an AL balance of over 520 hours. If you have no intention of using earned AL over the 520 hours there are options to donate the leave to someone that has requested a donation. Sometimes it is easier to simply use a few days of AL. If you are having trouble getting AL approved, contact the Union office. Management is required to make sure you do not lose AL. Sick leave can not be donated.

Anyone that is planning on retiring this year should contact Shared Services well ahead of the date they wish to retire. OPM suggests requesting the retirement application, known as the blue book, 6 months ahead of time. You must give a date that you wish to retire to get the application. Once you receive the blue book you should set up a consultation with Shared Services to help you fill out the application. Sometimes it is months before a consultation appointment is available. In general, the application is not difficult, but it is still suggested you set up a consultation in case you have any questions. If you have any questions about retirement, call the Union office or the Retirement Department at NALC headquarters.

Many carriers are not fully aware of the reason that they may receive FMLA paperwork in the mail, after certain absences. Management is required to designate your absence as pending FMLA if they have enough information to determine that the absence might be covered. This generates the paperwork to be sent to your last known address.

It is up to you to get it filled out by a medical provider and send it back within the timeframe allotted, usually 15 days. If you need more time, you can usually get an extension. Some carriers ignore this paperwork, but I suggest it should be filled out. The sole purpose of FMLA protection is that the Postal Service can't act against you because of the absence. In other words, the absence can't be cited on discipline. Please don't ignore FMLA paperwork if it arrives at home, call the Union office with any questions.

I just want to take a minute to recognize and thank Jim Nutter for his service to the branch. Jim has been the branch Treasurer for the past 36 years and stepped down from his position as of the end of December. Jim has been the only Treasurer I have known in the branch as I started my career in January of 1988, the same year he became the Treasurer. The branch financial records have been audited many times by the Department of Labor and we have always complied. Jim also made sure we were following the IRS rules, with the help of our accountant Jack Barry. Jim has left the branch financial records clean, and I wish him the best. Good luck to his successor James Metilinos.

At this point it looks like the negotiations for our national agreement will be going to arbitration, but anything can change. Any updates will be on the NALC website and app. Happy New Year to all I hope to see you at the branch meeting on January 9<sup>th</sup>.

Mental health, according to the CDC, includes our emotional, psychological, and social well-being. It affects how we think, feel, and act. Mental illnesses are among the most common illnesses in the United States. 1 in 5 teens (ages 13-18) currently or at some point have had a seriously debilitating mental illness. 1 in 25 U.S. adults live with a serious mental illness. There are over 200 types of mental illness, and while there is no one cause for mental illness, there are several risk factors. These include adverse childhood experiences, experiences related to chronic medical conditions, substance abuse, and feeling lonely or isolated.

If you live with a mental illness, or even if you don't, the holidays can be a challenging time for everyone's mental health. Especially for us letter carriers. Everyone experiences some stressors unique to the holiday season. Spoiling your kids can strain your finances. You may feel that once a year is too frequent to see some family members. You may feel that you don't have time to get it all done before Christmas Day. On top of all that, we letter carriers are working 60 to 70 hours a week, or more, to get the holidays delivered.

Fortunately, EAP is here to help. The EAP professionals offer counseling, consultation, and coaching services to help Postal employees manage the challenges we face.
