### President's Message

At just about the time that this issue of The Wake Up! is hitting your mailbox the NALC's 73<sup>rd</sup> Biennial National Convention will be kicking off right here in Massachusetts. This year's convention will be held at the Boston Convention Center from August 5<sup>th</sup> through the 9th. Branch 25 is sending 22 delegates. The National Convention is held every two years and is where the future direction of our Union is discussed and planned. Each branch around the country elects delegates to attend. Each elected delegate can vote on the proposed constitutional amendments, resolutions, and appeals that are brought forward to the floor. Every other convention there is an election held for National Officers. However, this year is not one of those years. The next National elections will be held at the 2026 National Convention. I'm not sure how many delegates will be in attendance in Boston, but usually there are somewhere around 6000 at each convention.

Each day there is a general session during the day. This is where all of the business of the convention is conducted. Additionally, before and after the general session each day there are classes and training sessions where delegates get information on a number of different issues. The delegates from Branch 25 run the gamut this year. There are some first-time delegates and some who have attended many previous conventions. Expect more information on the convention happenings from some of the delegates in the next issue of The *Wake Up!* 

This year is an election year for branch officers and shop stewards as well. According to the Branch 25 by-laws elections for shop stewards are to be held this October. Any member who has not served in a management position within the last two years is welcome to run for shop steward in their office. I would love to have a shop steward in all our offices. If you are interested in running for steward in your office or even just want to get some information on what the position entails and if you may be interested in representing the Brothers and Sisters in your office, please let me know. Many members have been asking what is going on with route adjustments in the branch. The TIAREAP process which was in place for the last two years is no longer in effect. The MOUs expired on June 1 of this year and were not extended. That means, at least for now, we are back to route inspections the old fashioned way according to the M-39. Currently in the branch we have had a few routes getting special inspections on route which have requested them. I am not aware of any plans that the Postal Service has to conduct full blown route inspections in any offices.

There have been rumors that some sort of process similar to TIAREAP will return in the near future, but those are just rumors at this point. There has also been talk that there will be a new agreed upon route adjustment process as part of our next collective bargaining agreement. Time will tell the tale. Until then I would encourage each carrier to deliver their routes as if the data may be looked at for the purpose of evaluating and adjusting their route.

Unfortunately some of the numbers that postal management gleaned from TIAREAP such as 22 minutes loading time and 1-hour office time are still being pushed on letter carriers. These numbers were never mandates on letter carriers. You will not find them in any handbook or manual. Even when TIAREAP was live they were only parameters for evaluation teams to look at. If local management is pushing these made up numbers in your office please keep in mind that they are just that...made up! I hope everyone enjoys the rest of the summer and we hope to see you at the branch meeting in September!

### **Executive Vice-President's Message**

I was hoping by this time to be able to report on the details of a new national contract, but as of this writing, no such luck. It would be nice if the agreement was resolved or arbitrated by now, but it is not out of line with the time frame of previous negotiations. Please, don't trust what you may hear on social networks about the negotiations or any possible agreements as accurate, until you hear it from the NALC. Information sometimes gets misinterpreted as it gets passed on. The last update on the NALC website said that the parties have reached agreement on many issues and are working to resolve the few remaining issues, although they are not releasing more details at this point. Hopefully, we will have good news soon. Until then we will still work under the current contract.

All carriers, both active and retired, will be receiving information about signing up for one of the Postal Service Health Benefits Program during open season this year. The NALC plan and Blue Cross plan have been included along with many others. The full list will be available and there will be more information on how to sign up coming to everyone by October we are told. The list of the plans that have currently been approved to be in the PSHB is on the OPM website. Everyone will be required to sign up for a plan or you will be assigned to a plan like what you currently have. We have a National Convention in Boston the week of August 5-9, and I expect there will be more information on this subject at the HBP seminars. I would hope that everyone picks the plan they desire and does not leave the choice up to OPM.

We have many carriers inquiring about transferring from one office to another. The rules apply differently from local transfers to transfers to other geographical regions. In order to be eligible to transfer locally, you need to be a career employee for 18 months. If you would like to transfer to another geographical region, you are required to have 1 year as a career employee. PTFs are eligible to transfer. Transfers are offered on a first come first serve basis, not based on seniority. When you do request a transfer there is a questionnaire that is sent to a manager in your station. There are 3 criteria that are looked at. Performance, Safety and Attendance. One of the questions asked is also whether the carrier has live discipline. All requests should be made on Liteblue, and you can request transfers to multiple stations. current vacancies are not listed on Liteblue, so if you

would like to transfer somewhere you should make the request. Transfers are generally not done overnight, so expect to have to wait, but the sooner you make the request, the higher you will be on the list for each station. Transfers can be denied by the gaining station, but the denial can be the subject of a grievance if the transfer is denied without good reason.

I hope everyone is staying hydrated, it has been a hot summer. A lot of our stations have been good about supplying bottles of water to carriers as they leave the office, but usually that is not enough. I always advise carriers to have their own supply of water and/or sports drinks in a cooler. We probably still have a couple of heat waves left so stay safe. The next branch meeting is on September 10<sup>th</sup> at the Knights of Columbus in Wilmington. There should be updates from the delegates to the national convention and as always food will be served at 7:15pm.

If you have friends and family in other states send out a text, email, social media post, or whatever way to get this message out and ask them to call their reps as well. Tell these politicians if they want your vote you need their vote and support for this bill. 

#### From the Treasurer's Desk

First and foremost, I'd like to apologize for not getting it out in my previous article, but a belated Happy Pride Month to all my brothers and sisters. Generally speaking, we've made many strides forward to help create an accepting and welcoming environment for all people and I've made many friendships with people from many different family and relationship dynamics. I was very happy to see the Postal Service sending out messages acknowledging Pride Month and encouraging celebration of who we are. I have a lot of respect for every LGBTQ+ carrier coming in and braving what can be a very divisive environment at times and being true to themselves. I hope it inspires others to do the same.

Obviously 2024 is a big year. Why? Elden Ring's Shadow of the Erdtree just dropped. And I guess the presidential election as well. We're about to see a massive influx of political mailings coming into each installation. Many installations are full of new hires in the last two or three years, so safe to assume, some of us might not know how political mailings are handled. Before I touch on that, I would like to preface this by saying that we are all bound by The Hatch Act of 1939 which keeps government functions and its employees nonpartisan. Federal law restricts the political activity of federal and postal employees while on duty, on postal property, wearing an official uniform or using a government vehicle. Many installations have been pretty lax regarding political opinions and things like hats, mugs, smaller flags and more with political affiliations. Just know that these items aren't permitted and your installation may (rightfully) instruct you to remove them. Now, with that out of the way; what are our responsibilities as letter carriers handling political mail?

First, ensure all available election/political mail is taken to the street for delivery on the day it is received. We treat all political mail as "first class", meaning we should not curtail it and it should be delivered with priority. Currently, 23 states hold some form of mail-in voting, with eight states requiring mail-in ballots be sent out. Massachusetts is not one that mandates mail-in ballots be sent out, but this should demonstrate the urgency to ensure our commitment to accurate and timely delivery.

Second, all balloting materials, including ballots, with or without sufficient postage must be delivered. Most of us are used to bringing parcels and mail with insufficient postage to a supervisor so they may collect what is properly owed. When it comes to ballots, this goes out the window. Democracy and exercising your right to vote is a constitutional guarantee. In 1870, African Americans were granted the right to vote through a constitutional amendment. In 1920, women were granted that same right, and as of 1971, the voting age was reduced to 18. We deliver ballots to those who are unable to go to a poll and exercise this right. Please, I cannot stress how

important it is, ensure these ballots are delivered in a timely and accurate manner. Many people will argue back and forth in favor of their political candidate they endorse, but in the long run, the only thing that truly matters is if you vote.

Lastly, ensure collection points and your vehicles are empty and no political mailings or ballots are left behind. Something I do at the end of my day is go to every door on my vehicle and open them. This ensures that if any mail or parcel has fallen or shifted, I'll find it. This becomes increasingly more important when election season is upon us. Some of us might remember, but back in June of 2020, President Trump put out a highly controversial tweet reading, "RIGGED 2020 ELECTION: MILLIONS OF MAIL-IN **BALLOTS** WILL BEPRINTED BY**FOREIGN** COUNTRIES. AND OTHERS. IT WILL BE THE SCANDAL OF OUR TIMES!" While this claim was unfounded and no evidence was ever produced to indicate the truth in President Trump's claim, we can counter these arguments by being proud of our work and taking the necessary steps to further ensure our election season is efficient and accurate.

By the time you receive this newsletter, our Biennial Convention will be taking place in Boston. If you find yourself with some time off, please, come down to the convention and see what the NALC is all about. We will likely hear about the status of collective bargaining for our new contract and the executive council will be addressing the membership on many, potentially controversial, things. We welcome all of our members to attend if they can. Enjoy the rest of your summer and prepare for the political mailings. I know during peak season the Postal Service loves to use the slogan, but when it comes to the presidential race and ballots, this is truly our season. Also, get out there and vote!

### Vice President's Report

The Letter Carrier Political Fund (LCPF) is an essential advocacy tool for the National Association of Letter Carriers (NALC), significantly influencing the legislative landscape for us letter carriers across the United States. By pooling resources from all us members, the LCPF supports pro union political candidates and legislation that prioritize the welfare of letter carriers, ensuring our voices are heard in the corridors of power.

One of the critical roles of the LCPF is to engage in effective lobbying efforts. This involves maintaining a sustained presence in Washington, D.C., and building relationships with key policymakers. These efforts ensure that the unique challenges faced by us letter carriers, such as labor rights, wages, health benefits, and retirement plans, are well-understood and addressed in legislative discussions. For instance, the Postal Service Reform Act of 2022, a significant legislative achievement supported by the LCPF, addressed the financial burdens of the U.S. Postal Service by eliminating the requirement to pre-fund retiree health benefits and integrating postal retirees into Medicare. These changes alleviated financial pressures and ensured the sustainability of benefits for letter carriers.

Another notable legislative victory influenced by the LCPF was the preservation of six-day mail delivery. Proposals to reduce delivery to five days a week have been periodically introduced as cost-saving measures. However, the LCPF's advocacy efforts have been instrumental in maintaining six-day delivery, which is vital for both the public and the job security of letter carriers.

While the LCPF is crucial for political advocacy, it is essential for us letter carriers to avoid violations of the Hatch Act. The Hatch Act restricts federal employees, including postal workers, from engaging in certain political activities to maintain the neutrality of public service. Letter carriers must be cautious to avoid partisan political activities while on duty or in uniform. Adhering to these restrictions ensures that letter carriers can effectively support the LCPF without risking getting in trouble for violating the Hatch Act.

The Letter Carrier Political Fund also fosters a sense of solidarity among us letter carriers. By contributing to the fund, individual letter carriers join a larger movement dedicated to protecting and advancing their collective interests. This unity is empowering, reinforcing the notion that collective effort can lead to significant changes and safeguard their profession.

The Biennial Convention will be taking place in Boston August 5<sup>th</sup> through the 9<sup>th</sup>. If you have the time, please come to the convention. If you would like to know more about the Letter Carrier Political Fund, this would be the perfect opportunity as there will be National Officers providing information about it.

Note: By making a contribution to the Letter Carrier Political Fund, you are doing so voluntarily with the understanding that your contribution is not a condition of membership in the National Association of Letter Carriers or of employment by the Postal Service, nor is it part of union dues. You have a right to refuse to contribute without any reprisal. The Letter Carrier Political Fund will use the money it receives to contribute to candidates for federal office and undertake other political spending as permitted by law. Your selection shall remain in full force and effect until canceled. Contributions to the Letter Carrier Political Fund are not deductible for federal income tax purposes. Federal law prohibits the Letter Carrier Political Fund from soliciting contributions from individuals who are not NALC members, executive and administrative staff or their families. Any contribution received from such an individual will be refunded to that contributor. Federal law requires us to use our best efforts to collect and report the name, mailing address, occupation and name of employer of individuals whose contributions exceed \$200 per calendar year. Any guideline amount is merely a suggestion, and an individual is free to contribute more or less than the guideline suggests and the union will not favor or disadvantage anyone by reason of the amount of their contribution or their decision not to contribute.


