







"You Read It Here First"

In the June-July 1997 (not a typo, that's 1997) issue of the "Wake-Up!" I wrote an article about what I called "K-vision". We had a POOM who's name began with a "K" who had issued a memo to Postmasters requiring them to forward to him the following information on late -leaving routes: route number, cased volume, office hours, office productivity, reason carrier left late, if carrier didn't make standard then why, and <u>action taken by supervisor</u>.

I suggested at the time that "Mr. K" should just set up videoconferencing gear at each carrier case and scan the thousands of feeds as he sipped his coffee in the morning. I suggested that carriers fax their 3996's directly to him and he could fax back instructions.

Finally, I said that although the micromanagement wasn't this extreme YET, it was almost here and you read it here first. Some time ago, when I learned of the command station of multiple screens tracking letter carriers movements in real time and watched by higher level management, I thought to myself that they had taken the next step towards "K-vision". Carriers weren't on video yet, and they didn't report directly to someone at the district or area level yet, but they may just as well be. Those managers watching the feeds contact local managers in real time and ask them for explanations for things like stationary time, and of course you know that means those local managers will be asking you for an explanation. Still, no cameras though...

Well, guess what? The Postal Service has informed the NALC that they intend to experiment with cameras attached to various parts of our vehicles, both inside and out. These cameras will be triggered by various actions, such as idle time, and they will record for a certain period of time each time they are triggered. They will also have the ability to be operated manually by someone in a remote location. It only took 22 years for my prediction to come true!

All kidding aside, think about this for a minute. Management will now have the ability to watch you during every single minute of your day. I wonder if they will text "God bless you" over the scanner if they see you sneeze. The branch will keep you posted as we receive more information about this program.

Speaking about programs, the case consolidation program has been slowed down for now. There has been a reduction in offices in phase 3 from over 200 offices to fewer than 60 offices. Peabody is one of the offices that has been postponed...for now. We still believe that the Postal Service will push forward with this program until and unless we are able to prevail through the grievance procedure, or any other means at our disposal. We will be prepared for the day that the program does arrive in the branch, it is urgent that you are prepared as well.

As I write this article, I am looking forward to Branch 25 Day at the Lowell Spinners game. The membership approved a motion to subsidize up to 75 members and their families for tickets to Sunday, August 18 which includes an all-you-can-eat barbeque before the game. I'm happy to report that 64 members have taken advantage of this offer.

I am sorry to report that there was not enough interest in the fundraising calendar for the scholarship fund. Only about 30 members and friends expressed an interest, so the project has to be scrapped. If you sent a check in, we will shred it unless you contact us to let us know that you want your check returned to you.

We will be discussing and voting on the by-laws that were published in the August edition of the Wake-Up! at the September meeting. Take the opportunity to attend the meeting and have a say in the Democratic Union process.

The final COLA adjustment for the current contract is \$624. That means that the seven COLA's for the 2016-2019 national agreement totaled \$2413. At the conclusion of the 2011-2016 national agreement, a top step letter carrier's pay was \$59,859. When the COLA rolls into our pay in September, the same top step letter carrier will be earning \$65,037. Almost half of our pay increase over the life of this contract are the result of COLA's. The postal service always tries to eliminate COLA's in the collective bargaining process and there are those in the federal government (our current president) who would like to see COLA's eliminated as well.

I have full confidence that our national officers will put forth the best arguments possible to preserve the COLA and to gain pay increases for us over the term of the next agreement. Negotiations are underway, and by the time you read this the negotiating period may be just about over. It seems, based on the other crafts and other indicators, that we may not end up with a negotiated agreement. It seems likely that our contract will be decided by an arbitrator.

As far as Congress and the president, we will have to continue to work very hard to protect our interests. One swipe of the pen is all it takes to change the way a COLA is calculated or to eliminate it altogether. We can do our part by contacting our Congress people, working to get our friends elected and re-elected, and contributing to the Letter Carrier Political Fund. Elsewhere in this edition of the Wake-Up! are forms to contribute to this fund, please do what you can.

Executive Vice President's Report

We just got back from the national rap session in Denver that included a long day of training by the national officers on Saturday, and President Fred Rolando spoke to the conference on Sunday morning. Fred made it abundantly clear that the 535 members of the House of Representatives and the US Senate are the most important people to the Postal Service and the NALC right now. They will be the ones to determine what kind of Postal Reform legislation will be passed. Any kind of reform has to be positive. foremost, the retiree health benefit pre-funding mandate has to be addressed. The pre-funding can't be done the way Congress mandated in 2006. The payments are unrealistic and are based on an inflated workforce. The most important piece of legislation that needs to be passed is HR 2382, The USPS Fairness Act. It addresses the pre-funding mandate. Also, the budget can not include proposals that include cuts to our benefits and retirements, as the White House would like. The White also would like to see letter carriers contribute a significant increase to our retirement benefits, resulting in a cut of pay. The White House also wants to eliminate collective bargaining. That can't happen. These are just a few things that Fred mentioned, but I think you get the picture. We have a lot of friends in Congress, but we need to keep them. Postal issues are non-partisan as they affect virtually everyone in the country, and the members of Congress that represent each district of every state will be the ones voting on the legislation. Votes and money are the 2 key components to keeping our friends. Unfortunately, it takes money, but that is a reality today. I'm sure there are plenty of 3999s being conducted on carriers' routes this summer. The wizards in OPS like to instruct managers to do these this time of year, and act as if they can actually adjust routes based on a one-day walk if the time is to their liking. Like any 3999, it is just a one-day walk that can't be used to evaluate your It is still important to do your route by the manuals every day. We don't know if the case consolidating test will become widespread, but if so, the times used by the regular carrier will probably be important. Don't skip breaks or conduct any street time in the office or off the clock. Make sure your time punches are as accurate as possible. The NALC has filed many grievances on this project by the USPS, but it may be months before we get any results.

There was a brief presentation in Denver on the new vehicles that are to be built to replace the LLVs. The contractors have finalized their proposals to the Postal Service and now it is time for the service to choose a model. We don't have any idea what the final model will look like, but the delivery of the first new vehicles will probably be about 18 months after a model is chosen. We were shown the final 4 designs that were presented to the Postal Service but they were all very

different from each other.

We have so many newly converted career employees in the carrier craft as of now, it is hard to keep up with it. At the Denver conference we were told that a very high percentage of these carriers are not taking advantage of the Thrift Savings Plan. This is probably the easiest way to ultimately save for retirement without too much pain. The Postal Service will match up to 5 percent of the employees contribution to the TSP. We have 3 components to our retirement package as a FERS employee. The annuity and Social Security are the first 2 and are based on service time. The TSP can grow to a large sum of money if taken advantage of from the beginning of your employment. Please take advantage of the match from the USPS, if not you are losing free money.

"We Work Hard For Our Money"

From the day we started our careers with the Postal Service we have been working hard to provide for our families. Forty-hour work weeks to sixty-hour work weeks, it did not matter as long as we were able to take care of our children and our spouses. We also worked hard to save, invest, and prepare for the long-awaited day when we could hang up the satchel and retire.

Knowing we worked to do what we had to do and retire to do what we want to do. In order to achieve this great milestone, we need to be aware of those that would like to take advantage of our money. Many of us have money in the Thrift Savings Plan that supports the third leg of our retirement. But there are companies that will send us information in the mail, disguise themselves as reputable businesses that are associated with the postal service, and attempt to get us to invest our thrift money with them. They sell themselves on the ability to make us more money when, in reality, they are just trying to make themselves more money. Fees, commissions, and penalties eat away at what we have worked so hard at saving. In the end, we have less.

Then there are the lawyers who want to "help you" achieve riches through on the job injuries. Many, if not all of us will suffer an on-the-job injury at some point in our career. If so, we are entitled to apply and receive compensation for those injuries through scheduled awards. If we are not careful and we do not utilize the compensation specialists provided by our union, we could forfeit 25, 30, up to 40 percent of our scheduled

award.

Let's not forget the politicians in Washington, DC. There are many that wish to balance budgets or pay for tax cuts on the backs of letter carriers. We need to stay educated on what is happening in DC and be aware of how their intentions will affect our ability to enjoy an early retirement. We need to protect ourselves from the current proposal to reduce a CSRS member's yearly COLA by ½ percent per year and to eliminate a FERS member's entitlement to a COLA completely.

There is also a proposal to eliminate the FERS supplement that allows a FERS employee to retire at our minimum retirement age with 30 years' service by providing a supplement that approximates our social security benefit at age 62. This proposal would affect current FERS retirees as well as future FERS retirees.

There are so many more, but most devastating is the current administration's desire to destroy the Postal Service and take away our livelihoods. We are the ones that need to fight to protect our future. We can not rely on the Postal Service to do it; they seem to work against the protection of service.

In order to protect the hard-earned money and benefits we have worked so hard to achieve, to protect the future of the Postal Service so that others can achieve the same, we need to stay informed. Read the Postal Record, contribute to the Letter Carrier Political Fund, and educate ourselves, our families, and our co-workers on what to be cautious of.

"Back To Work"

As carriers, we hear enough about improper lifting, but what are some other back pain risk factors?

I was surprised to see smoking on the list. Smoking reduces blood flow to the lower spine, which can keep the body from delivering nutrients to the disks in your back. Smoking also slows healing. Excess body weight, lack of exercise, depression, and anxiety are some of the other risk factors.

What I call a "tweak" is actually a back spasm which is the involuntary contraction or tensing of the muscles in the lower back. Back spasms can be the result of injuries to the muscles, tendons, and ligaments in the back, or they can be related to more serious medical conditions. Of course, seeing a doctor is recommended if the pain is ongoing and severe.

If you do have back pain, there are some things you can do on your own to deal with it. You can apply heat or cold to the back. There is no science as to which is better. It may be best to alternate the two. You can improve posture when standing and sitting. Roll the shoulders back and straighten the spine when you find yourself slouching forward. Over the counter pain medication can help as well. Motrin and Advil are good when you have back pain because they are antiinflammatories. Tylenol will relieve the pain as well.

Exercise can help us with preventing back pain and healing back pain. When you're healthy, strength training and Pilates are great because they strengthen your core muscles. After an injury, start with stretching and yoga until you feel strong enough to do more physically demanding exercises. Keep yourself and your back safe,

While all EAP services are confidential and are held to the highest level of confidentiality at the state and federal levels, some people are struggle with self-consciousness or have difficulty verbalizing their feelings in front of others. By working with an EAP counselor over the phone, many people feel more freedom to express themselves than they have face-to-face.

Counseling by phone allows you to get the help you need without having to see a therapist within your community. If you are concerned about the stigma attached to mental health problems or you are worried that someone may find out you are receiving counseling, telephone counseling services offer you a higher level of privacy as well as leaving you the option to remain anonymous.

Some people may feel unsure if counseling is right for them if they have never been in counseling before. Telephonic counseling provides a perfect environment for these individuals to find out if counseling is right for them, sort of like a test drive.

Making the decision to get help is the first step. Making the call is the next step in getting the assistance that you need. Contact the EAP and let them know you are interested in telephonic counseling. You can find out if the service is right for you and they can help you get started.

Vice President's Report. I would like to start off this month's report by giving an update on some of the congressional resolutions effecting letter carriers I mentioned in the June-July issue. H.R. 2382 (USPS Fairness Act) may be the most important of them. This would repeal the Postal Service's requirement to pre-fund future retirement benefits. As of now there are 213 co-sponsors; 182 Democrats and 31 Republicans. We will need more Republican support to get where we need to be with this one. That is not always easy but hopefully as more co-sponsors join in other members will see that this makes sense and sign on too. The unofficial goal is to get to 290. At that number a resolution becomes automatically up for consideration on the floor. H. Res. 33 (anti-privatization) is up to 259 co-sponsors. H. Res. 54 (protecting 6-day delivery) is up to 272 co-sponsors. H. Res. 23 (maintaining door delivery currently has 240 co-sponsors. H. Res. 60 (service standards) is up to 188 co-sponsors. Congress is currently on their summer recess until early September so nothing will be happening until then. Hopefully these important letter carrier issues will continue to make progress with the help of our friends in Washington and the support of letter carriers and the NALC.

Some of you may have heard about the USPS program called Case Consolidation. This is an initiative where the Postal Service is looking to save physical space in carrier units and cut Dan Wheeler office time from carriers' routes. Instead of each route having

its own case there is one case used for multiple routes allowing the Postal Service to take away equipment. They will also be taking away routes as they reduce office time. Carriers are split into 2 groups, "casers" who come in early to case the mail and "streeters" who come in later to deliver mail. This has been going on in Annandale VA for almost 2 months now. By the time you read this it will have started in our region as well. In the last 24 years as a letter carrier I have seen many new things; DPS, FSS, increased parcel volume, scanning and GPS among others. In my opinion this program would change our jobs more than any of these other things that have been introduced! The NALC is working hard to stay on top of this. They have people in the field to make sure things are being done properly and all relevant grievances are being filed. This program is still very new so stay tuned for more information.

Finally, I would like to congratulate a carrier from my office in Holliston on her well-deserved retirement. Dee Jack retired on July 31 after 32 years of delivering mail. Dee was a great carrier and will be missed but I wish her all the best in her retirement.
